### **Expanding Housing Protections for All Illinoisans**

In Illinois, landlords can discriminate and deny housing to people who pay for their housing with social security, veterans benefits, child support, Housing Choice Vouchers, or any other type of non-wage income. This is known as source of income discrimination in housing. At a time when housing costs are increasing, it's urgent that we ensure no one is denied a home.

**HB 2775 ensures that persons utilizing legal sources of non-wage income to pay for housing will have equal access to the full range of rental housing available to them.** HB 2775 focuses on the core source of income protections that 19 other states already have. This would bring the State into alignment with existing source of income protections under Cook County and City of Chicago.
